 - (c) To provide the Minister of Tourism, Economic Affairs, Traffic and Telecommunication an annual profit and loss statement and balance sheet.
 - (d) To provide the Minister of Tourism, Economic Affairs, Traffic and Telecommunication at least annually a complete list of all stockholders, partners, directors, and members of the board.
 - (e) To report to the Minister of Tourism, Economic Affairs, Traffic and Telecommunication any change in personnel who have been previously approved.
 - (f) To make available for inspection by the Minister of Tourism, Economic Affairs, Traffic and Telecommunication and its authorized personnel at all reasonable times all information relative to the operation of the lottery.
